Dear Mr. Tucker,

My recent experience at Seabrook Nuclear Power Station revealed it is wholly unprepared if a member of ISIS or another extremist group walked onto the grounds with bad intent.

On Friday October 17, 2014 at 2:26 pm I arrived at the unmanned security gate. After waiting 25 to 30 minutes a truck finally approached, I could only assume it was security. But to my surprise, it was an independent contractor onsite to finish a job for Seabrook Station. When I explained how I wanted to visit the educational center, he said, "at the end of the road take a right." The most troubling aspect of our conversation came when he said nobody was ever in the security booth. Everybody drives by the booth, nobody is ever there.

Once inside, I found the educational center closed. I continued on a ramp to the administration complex until I reached a glassed in reception desk area which was empty just as the security post had been. When I spotted the phone and a three-ring binder, I began dialing office numbers. After several messages claiming this person was on vacation or not receiving no calls at all, I spotted a man approaching the desk. I inquired if he was security. As is happened, he was a computer programmer. He explained how half the staff are given every other Friday's off.

When he asked if he could help with anything, I told him, "I am the founder of the National whistleblower Organization, We The People. Working with whistleblowers from Seabrook station, we successfully shut this plant down for falsification of weld records.

Just as I finished speaking another man approached. This time it was a member of the security team. I told this man the same thing I had just finished explaining to the programmer. As I spoke, the man covered his name badge with his hand. I went on to add, I believe the CEO would be interested to know seventy of We The People's signs have been stolen. Every stolen sign is a mark against the American freedom brave men and women have died to preserve. I had a packet with me containing five police reports from Rowley, Newbury, Salisbury, Seabrook and Hampton beach. If I were the CEO of Seabrook Station I would want to know how people's rights are being violated. He promised to bring the envelope to his boss.

I left Seabrook Station at 3:35 pm without incident. At no time, did I ever witness a security vehicle in patrol of Seabrook Nuclear Station.

As I drove away, I couldn't help but think, what if I were someone with intent to sabotage a volatile energy source such as nuclear power. Who would have stopped me?

I have reported this incident to police and fire departments of Hampton, Seabrook, Salisbury, Newburyport, Newbury, Ipswich, Rowley and the Nuclear Regulatory Commission.
